**HISTORY.** This publication supersedes Redstone Arsenal Policy 200-3, 9 December 2014.

**SUMMARY.** This policy establishes the hunting, fishing, and trapping plan for Redstone Arsenal (RSA). It establishes policy, procedures, and responsibilities for all activities to ensure compliance with federal, state, and RSA laws and regulations.

**APPLICABILITY.** This policy applies to all organizational elements, including tenant activities, on the installation.

**PROPONENT AND EXCEPTION AUTHORITY.** The proponent of this policy is the Chief, Environmental Management Division, Directorate of Public Works, US Army Garrison-Redstone (USAG-RSA). The proponent has the authority to approve exceptions to this policy that are consistent with federal or state law or regulation.

**MANAGEMENT CONTROL PROCESS.** This policy does not contain management control provisions in accordance with Army Regulation 11-2. This Policy will be reviewed and published annually prior to the start of the fall hunting season on or about 1 SEP.

**SUGGESTED IMPROVEMENTS.** Users are invited to send comments and suggested improvements on DA Form 2028 (Recommended Changes to Publications and Blank Forms) to USAG-RSA, Directorate of Public Works, Environmental Management Division, (IMRE-PWE), Redstone Arsenal, AL 35898.

**DISTRIBUTION.** This publication is approved for public release; distribution is unlimited.

#### 1. PURPOSE.

a. This policy establishes policy, assigns responsibilities, and prescribes procedures for hunting, fishing, and trapping on RSA.

b. Seasons, hours, legal game, daily bag limits, hunting ages, and possession limits for all game and fish are set by federal and state laws and regulations.

c. All federal and state laws on hunting, fishing, and trapping apply to RSA. This policy, as well as special notices, rules, and procedures are posted at the Outdoor Recreation Branch, also apply to RSA.

d. Installation hunting, fishing, and trapping activities may be closed, as necessary, in support of installation activities, training, or security requirements.

#### 2. RESPONSIBILITIES:

a. The USAG-RSA Commander manages and directs hunting, fishing, and trapping on RSA. Any exceptions or special requests to this policy must receive approval from the Garrison Commander.

b. The Directorate of Operations, with USAG-RSA Conservation Officers as its authorized agents, is the proponent for enforcement of all hunting, fishing, and trapping regulations as well as aiding in control of nuisance wildlife and conducting studies related to wildlife and habitat management in conjunction with the RSA Garrison Wildlife Biologists. All activities related to nuisance wildlife control, depravation hunts or scientific studies are exempt from all hunting and fishing permits and license requirements. The Directorate of Operations will:

(1) Function as the central organization for collecting and reporting of hunting area availability.

(2) Create a weekly hunting area availability report using a weekly standing data call. All Redstone organizations identified with missions using hunting areas will provide input identifying such areas necessary to close on a day by day basis for one week ahead of the report effective date.

(3) Disseminate the weekly hunting report to the Safety Office, Directorate of Public Works (DPW), Directorate of Operations and MWR Outdoor Recreation.

(4) Take reports for daily changes in hunting availability due to mission requirements that could not be predicted in the weekly report. Coordinate these daily changes with Outdoor Recreation.

(5) Register weapons.

c. The Directorate of Family and Morale, Welfare and Recreation, with the Outdoor Recreation Branch as its authorized agent, administers the hunting, fishing, and trapping programs to include:

(1) Maintaining HuntTrac/TeleTrac call in hunting area assignment system.

(2) Sale of RSA hunting permits.

(3) Control access of hunters, trappers, and fishermen.

(4) Post hunting areas in HuntTrac.

(5) Provide RSA Hunting and Fishing Policy/ uponrequest

(6) Conducting annual hunter safety orientations for all Redstone hunters prior to the beginning of each annual hunting season. Orientations may be requested periodically throughout the season upon request for new hunters unable to attend pre-season orientations.

(7) Implementing "on-the-spot" changes to the size, numbers and sex of deer taken during the hunt, as directed by the USAG-RSA Wildlife Biologists.

(8) In conjunction with the Directorate of Operations, collecting weekly reports from DPW, DPW approved reporting contractors, and Redstone tenant organizations to prepare for utilization of restricted areas for hunting and fishing when they become available.

d. DPW is responsible for:

(1) Establishing responsible points of contact for reporting hunting areas needed to be closed for mission requirements NLT 45 days prior to the beginning of hunting season. This report will meet established hunting requirements and schedule and will be made available to the Directorate of Operations.

(2) In coordination with Contracting Officers Representatives and Contracting Officers, establish a process for selected larger contractors working over the entire installation and who control their own work schedules to be able to report their work requirements in hunting areas directly to the Directorate of Operations.

(3) Reporting changes to the availability of hunting areas due to DPW mission requirements to the Directorate of Operations, as soon as a change is identified.

e. DPW, Environmental Management Division is responsible for:

(1) Conducting all fish and game management activities, to include the upkeep of food plots, wildlife clearings and designating fishing areas on RSA.

(2) Coordinating with federal and state officials to set the dates of game harvest within the boundaries of RSA.

(3) Setting hunting quotas, creel limits and restrictions as necessary for proper management of all species according to accepted wildlife science and ecological principles.

(4) Designating trapping areas, allowable species, and trapping quota.

(5) Biologist will maintain harvest data.

(6) Controlling nuisance wildlife under current state and federal permits. These actions are exempt from all RSA hunting, fishing, and trapping permit and license requirements, including those duties performed by the US Department of Agriculture Wildlife Services.

(7) Conducting studies related to wildlife and habitat management. These actions will be exempt from all RSA hunting, fishing, and trapping permit and license requirements.

f. All Redstone tenant organizations controlling hunting lands on RSA for mission activities are responsible for:

(1) Establishing a single point of contact responsible for reporting to the USAG-R

Directorate of Operations (DoO) hunting area availability and utilization, and meeting established reporting schedules.

(2) Make available for hunting purposes all hunting areas not directly and immediately required for mission.

(3) Reporting unexpected changes to the availability of hunting areas for recreation to Directorate of Operations as soon as a change is identified, to ensure that workers and hunters are safely in and out of the affected areas respectively.

g. All authorized hunting, fishing, and trapping persons, to include guests and family members, on RSA will know and abide by federal and state laws and this policy. By receiving/accepting a RSA Hunting/Fishing/Trapping Permit, the receiver agrees to abide by all applicable laws, regulations and this policy.

h. Sponsors are responsible for the conduct and safety of their guests/Family members. Penalties assessed for violations committed by guests/Family members will also be assessed against the sponsor.

i. Weeden Mountain areas 7E and 7W are designated as co-usage areas. Co-usage areas enable the land within the designated boundaries to provide year round activities for multiple uses i.e. hiking, mountain biking, trail maintenance etc. During hunting season, hunters should be aware that these other activities may be taking place and should remain mindful of other users.

### 3. PROCEDURES.

a. Eligibility to hunt, fish and trap on RSA, including the Wheeler National Wildlife Refuge (NWR) portion.

(1) Active/Retired Military, their dependents (with ID card), guests (no more than two) and reserve components while on Active Duty training status (not weekend drill) may hunt, fish and trap. Guests and dependents must be sponsored and accompanied. Dependents must be under the age of 22, unless a spouse of the sponsor.

(2) Civilian/Retired employees (no guests) of the United States Government assigned to RSA and their accompanied dependents (under age 22 unless a spouse) may hunt, fish and trap (no waterfowl hunting).

(3) No one under age 9 may handle a weapon.

b. Licenses and Permits.

(1) RSA Hunting and trapping permits, required if 16 years old or older, are available at the ODR, Building 5139.

(2) State Licenses/Stamps as required by state law.

(3) Hunter education certificate (any state or Europe) as required by state law.

(4) RSA Hunter Safety Orientation Card (certain exceptions may apply)

(5) RSA Weapons Permit if using shotgun, muzzleloader or pellet rifle. Not required if using archery.

c. Children between the ages of 9-15 may participate in youth hunts.

d. Hunting.

(1) Hunting is authorized in designated areas only. There will be no hunting on Tuesdays or Wednesdays, except select holidays.

(2) Hunters should request a hunting area by logging into the HuntTrac system to find an available area. Active Duty may reserve an available area between 1700-1800 for the next day's hunt. All others may reserve an available area after 1800.

(3) Dash placards will be clearly displayed on the vehicle dash. Hunters must clear hunting areas within the prescribed time limits.

(4) Special hunts will be announced at ODR.

(5) Hunters hunting within Wheeler NWR, will hunt only in the portion identified on the map with corresponding area numbers, e.g. hunters in Area 55 may also hunt in Area 55R. Only deer and raccoon (non-toxic shot #6 or smaller for raccoon) may be hunted on Wheeler NWR lands.

(6) Hunters may, after contacting a Conservation Officer or ODR and getting approval, look for wounded game in another open hunting area.

(7) Hunters must report all wildlife taken at the end of each hunting day on the harvest form at ODR. Bucks must have at least a 15" outside spread or at least one antler with a 15" main beam length. All deer and turkey must be checked by an ODR staff member or a Conservation Officer prior to the animal leaving RSA. The hunter that harvests a deer or turkey must check the animal in prior to donating to anyone else. Does must have milk sac intact.

(8) Hunters will not: Cut trees, use more than 4 dogs while small game hunting, drive/participate in deer drives, construct/use permanent blinds/tree stands, leave hunting equipment in the field overnight, destroy evidence of sex of deer or turkey,

discharge a weapon in an unsafe manner, hunt in unauthorized area, tamper with any property not their own, loan/alter any official document pertaining to hunting, fishing or trapping, use/possess/be under influence of any intoxicants or substances, drive vehicles into food plots, block roads/gates/firebreaks, use unauthorized equipment or violate federal/state laws.

**e. Weapons and Ammunition.**

(1) Only shotguns (10 gauge – 20 gauge) muzzleloaders, pellet rifles and archery equipment may be used for hunting. Hunters must use weapons/ammunition/archery equipment that complies with federal/state law which also corresponds to the animal species they are hunting. However, shotgun/rifle combination firearms are not allowed for possession/use on RSA. Buckshot, no larger than 00 buck, is authorized for use on coyotes from 1 May – 30 September. Use of pellet rifles are limited to squirrel hunters and trappers.

(2) Weapons (archery equipment is exempt) must be registered with DoO-Div. of Law Enforcement where a weapons permit will be generated. Hunters will observe a 300 foot minimum distance from buildings, structures and boundaries. Hunters will not fire from or across any road.

**f. Turkey.**

(1) Season: Spring season only – Alabama State Law dates.

(2) Bag limit: One per day. Quota/limits established annually by Wildlife Biologist.

(3) Turkey hunters are required to wear a cap/hat of hunter orange while walking to/from set up sites. Once stopped and set up, the orange cap may be removed.

(4) Legal weapons, ammunition, prohibited methods and devices is per Alabama State Law.

(5) Turkey hunting is allowed between sunrise and 12 noon.

**g. Deer.**

(1) Season: Per Alabama state law

(2) Bag Limit: Quotas, limits and buck restrictions are set annually by the Wildlife Biologist in conjunction with applicable Alabama state law.

(3) Safety Garments: Per Alabama state law.

(4) Prohibited Methods and Devices: Deer decoys, game cameras and salt



(including Trophy Rock) are prohibited to use or possess on RSA. Other prohibitions are per Alabama state law.

(5) Hunting may begin 30 minutes before sunrise and ends 60 minutes after sunset. Holiday hours end at 12 noon.

(6) RSA residents may dispose of non-edible animal parts in authorized wooded areas at least 1,000 feet from any road or building. Those not living on-post must dispose of remains off-post. This does not prevent hunters from field dressing animals while still in their assigned hunting area if desired.

h. Beaver, Groundhog, Coyote, Feral Hog, Feral Cat and Skunk.

(1) Per Alabama state law using weapons and ammunition authorized for use on RSA. (Part e. sections 1 & 2 apply)

i. Raccoon and Opossum.

(1) Per Alabama state law. Note: While on Wheeler NWR, Part d. section (5) applies.

j. Other Game Species.

(1) Mourning dove, quail, waterfowl, squirrel and rabbit.

(2) Per Alabama state law, however Part e. Sections 1 & 2 still apply.

(3) Dogs may be used to hunt the above listed species. Hunters must have owner contact information on the collar of each dog used. If a dog cannot be retrieved at the end of the day's hunt, the dog's owner must contact RSA Police at 256-876-2222 or Dispatch at 256-544-4356, report that dog as not retrieved, and give officials contact information. When notified by a RSA official that their dog has been located, the dog's owner will respond promptly to retrieve the dog. Failure to follow this procedure may result in a suspension, inability to use dogs in the future, or both.

k. Fishing.

(1) Fishing is authorized in designated areas which are posted at ODR. Bradford Sinks availability is posted on the weekly range report. When Bradford Sinks is open, anglers must sign up in person at ODR before going to fish. Creel/size limits, equipment and methods are per Alabama state law. Boats are limited to electric motors or manual propulsion on RSA. A state fishing license is required for those 16 – 64 years of age.

**I. Dog Training.**

(1) The Wildlife Biologist and ODR must approve dog training with No Training occurring during turkey season or the months of May and June. Alabama state law applies in addition to the aforementioned requirements.

**m. Scouting.**

(1) Scouting is permitted during daylight hours only after processing through ODR and obtaining permission to scout. Use/possession of weapons, calls or decoys is prohibited when scouting. There will be no scouting once archery deer season begins.

**n. Trapping.**

(1) Trapping is permitted in designated areas only which is posted at ODR. Those wanting to trap, will submit a written request to the Wildlife Biologist and ODR. If approved, trappers will provide a map showing trap locations to ODR and notify ODR when traps are removed.

(2) Trappers will provide the Wildlife Biologist and ODR a weekly report listing all animals trapped that week. Traps will be checked daily and marked with owner information.

(3) Alabama state law applies in addition to the above listed requirements. There is no trapping allowed on Wheeler NWR.

**o. Safety.**

(1) ODR staff, Conservation Officers and Police Officers will refuse/cancel permission to hunt, fish or trap to anyone suspected of using, possessing or being under the influence of any substance that compromises safety.

(2) Boats launched from or on RSA will conform to all applicable federal and state requirements. Hunters using boats to access a hunting area, must launch from RSA, place dash placard in vehicle at launch and also leave the same information clearly visible on the boat. Use of an approved PFD is required while boating.

(3) No person will attempt to touch or move any item of equipment not belonging to them. Those encountering suspected UXO or any suspicious item, will not touch the item(s), will mark the location and notify authorities.

(4) Hunters using tree stands must use a safety belt/harness that can support the hunter's weight and shall be attached to the hunter and tree at all times when the hunter is not on the ground.

(5) No hunter shall drive, drill, screw or otherwise insert any metal object into a tree or hunt from a tree which has been prepared in such a way.

(6) Anyone involved in/knowledge of an unsafe shooting incident will report the incident to the Military Police and ODR immediately.

(7) Those having knowledge of in-progress wildlife violations or violations less than 90 days old, should report such violations to Conservation Officers. Failure to report may result in a suspension of privileges per the discretion of the Garrison Commander.

## 2019-2020 RSA Hunter Handout

**Who may hunt:** Active/Retired Military, their dependents (with ID card), guests (no more than 2) and reserve components while on Active Duty training status (not weekend drill) may hunt, fish and trap. Guests/dependents must be accompanied by sponsor. Active/Retired service members may sponsor up to 2 guests for a 72 hour period without those guest(s) obtaining a hunting permit or orientation. The sponsor is responsible for the guest(s) conduct and adherence to policy and law. Violations by guests may result in penalties assessed against the sponsor.

Civilian/Retired employees of the US Gov't assigned to RSA and their accompanied dependents (under age 22 unless a spouse) may hunt, fish and trap. No guests or waterfowl hunting.

Contractors (and dependents under age 22 unless a spouse) that work full-time on RSA with a completed contractor form verifying an active RSA contract and full-time, on-post employment. No guests or waterfowl hunting.

**Weapons Allowed:** Only shotguns, muzzleloaders, archery and pellet rifles may be used for hunting. No shotgun/rifle combination weapons are permitted. All ammunition/equipment must comply with applicable state/federal law. Deer - shotguns 10 ga – 20 ga using slugs, archery and muzzleloaders; Turkey – shotguns 10 ga or smaller and archery equipment; Game birds/migratory birds – shotguns 10 ga or smaller. Other game/non-game animals – shotguns 10 ga or smaller, archery/muzzleloader. RSA hunters and trappers may use pellet rifles no larger than 22 cal for squirrel hunting/dispatching trapped animals. Use of BBs is not allowed. Those using firearms/muzzleloaders/pellet rifle must be background checked and weapons permit issued from the Div. of Law Enforcement at building 3623.

**General Info:** Hunters must sign in/out thru HuntTrac system. All hunters, anglers and trappers are required to ascertain availability of areas prior to entering them. All animals harvested are required to be reported on the harvest sheets at the end of the day's hunt prior to leaving RSA. Hunters, anglers and trappers must have the required licenses/permit in their possession while engaging in those activities. Game cameras and permanent stands/blinds are not allowed. Don't drive off-road or into food plots. Use of/possession of bait, salt etc. while scouting or hunting is prohibited. Hunters, anglers and trappers are expected to know and abide by applicable laws pertaining to the activity they are participating in. Violations of law/policy may result in citation(s) being issued, a suspension of privileges and/or both. More information is available in the full Hunting, Fishing and Trapping Policy on the MWR website.

Weeden Mountain areas 7E and 7W are designated as co-usage areas. Co-usage areas enable the land within the designated boundaries to provide year round activities for multiple uses i.e. hiking, mountain biking, trail maintenance etc. During hunting

season, hunters should be aware that these other activities may be taking place and should remain mindful of other users.

**FBI Area:**

Hunters should not be within 100 feet of fencing surrounding explosives magazines/bunkers (Buildings 8905, 8912, 8913).

Hunters should not be within 100 feet of the fencing surrounding Buildings 8990, 8991, 8991A.

Hunters should not be within 100 feet of the TEDAC explosives range. (Circular area depicted on map)

Hunting may take place on Friday, Saturday, Sunday and Holidays if the area is open on the weekly Range Report.

Hunters may enter the hunting area on foot only from the north, west or south.

If a hunter has game down or wounded that is within the allowable distance of one of the above listed exclusionary areas, they must contact a Conservation Officer prior to searching for or retrieving game.

In keeping with the long established policy of all Redstone hunters having a working cell phone with them at all times when hunting, it is especially important that in the event it becomes necessary to contact hunters and have them leave the FBI controlled area, that all hunters monitor their phones for unexpected information.

**Areas 65-67-69:**

New areas are currently marked with Environmental Office signage. The numerical signs already indicate the corresponding hunting area. Example... Environmental site/compartments 65 corresponds to new hunting area 65. Hunters will use and be held accountable for being in their correct and signed in area using these markers.

Hunters/anglers that encounter any suspicious object or substance will note the exact location and report it immediately to proper authorities. Do not touch, move or remain close to the object.

When Area 67 is open for recreational use, Igloo Pond will also be open for fishing and hunting uses.

Under no circumstances, will ANY litter, to include spent shotgun shells, be left in these new areas.
